MINUTES OF THE MEETING ABOUT THE REVISED FEE STRUCTURE HELD ON 01.06.2023 AT 04.00 P.M AT THE DIRECTOR'S P&D CHAMBER

The following members were present:-

1. The Dean, CEG Campus
2. The Dean, MIT Campus
3. The Dean, ACT Campus
4. The Dean, SAP Campus
5. The Director, Centre for e-Governance, AU.
6. The Director, Centre for Constituent Colleges, AU
7. The Director, Planning and Development
8. The Additional Director, Planning and Development

The Director, P&D welcomed all the members.

As per the Resolution no.142.12 of Finance Committee meeting held on 18.01.2023 and Resolution no 266.9 of Syndicate meeting held on 19.01.2023, the Fees structure has been revised and the same was communicated to the Deans of all Campuses, the Director, Centre for e.Governance and the Director, Centre for Constituent Colleges.

In this connection, certain queries have been raised by the Deans of all campuses and the Director, Centre for e-Governance. Hence, the meeting was convened to sort out the issues.

The following decisions were taken in the meeting

- i. The Term Fees which is collected every semester, the mention of "Entrepreneurship Development fee (One Time Fee)" is to be revised as "Entrepreneurship Development fee" in all the Annexures for both University Departments and Constituent Colleges in the circular no: 102/Misc/PD4/2023-1, dated:15.05.2023.
- ii. "M.E./M.Tech – (GATE) Full Time" to be revised as "M.E./M.Tech – (GATE – Regular & Self Support) Full Time" in the above referred circular.
- iii. The revised fee structure is also applicable for other state & NRI candidates as it is for Tamilnadu candidates. Recognition, Registration and Enrollment Fee (Sl.No:9) for Tamilnadu candidates was increased by Rs.800 (i.e it was revised from Rs.1200 to Rs.2000). Similarly, it is to be increased for other state & NRI by Rs.800 (i.e for other state candidates revised from Rs.1700 to 2500 & for NRI candidates revised from Rs.2500 to Rs.3300).

- iv. For M.E / M.Tech GATE & NON-GATE candidates Term fee was increased by Rs.200 per semester. For M.Arch / M.Plan the increase was not spelt out clearly as GATE and NON-GATE. The fee mentioned for M.Arch/ M.Plan was equivalent to that of M.E / M.Tech NON-GATE category. So the mention of "M.Arch / M.Plan (Regular)" has to be revised as "M.Arch / M.Plan (Regular & Self Support – Full Time – NON-GATE)" and whereas for GATE candidates the fee increase of Rs.200 is to be collected over and above the year 2022 fee collected for GATE candidates and the revision in sub-heads of one-time fee, caution deposit and term fee are as per Annexure enclosed (similar to M.E GATE candidates). The Rs.200 increase for GATE candidates may be placed in Finance Committee and Syndicate for information.

The members suggested to **INCLUDE** the following footnotes:

1. 7.5% Reservation is to be followed as per Government norms.

The members suggested to **MODIFY** the following footnotes:

1. Members suggested to modify "Post Matric Scholarship and Differently abled students are exempted from paying semester fee (payable every semester)" in to "Differently abled students are exempted from paying semester fee (payable every semester) but they shall pay Sl.No 08,09,10 and 11 in one time fee (payable at the time of admission) along with Caution deposit (refundable)".

The members suggested to **REMOVE** the following footnotes:

1. All the UG (Full Time) students have to pay an additional fee amount (CEG - Rs.2,500/-, ACT - Rs.1,100/-, MIT - Rs. 1,100/- and SAP - Rs. 1,700/-) towards Induction Programme at the time of Admission.
2. Students of B.Arch. have to pay an additional fee of Rs.3350 towards Stationary Materials (Rs.3100) and Rotaract Club of SAP (Rs.250) at the time of Admission.
3. All the students of Full Time B.Arch / M.Arch / M.Plan have to pay an additional fee of Rs.325 every semester towards SAP Association and Archilogue.

The footnotes finalized by the Committee members are given below:

1. Caution deposits are refundable on completion/ discontinuation of the programme on application through online process using the login id (provided for individual students). If the refund is not claimed within one year from the completion/discontinuation of the program it will be treated as lapsed deposit.
2. Co-operative Society Membership Fee is not applicable for B.Arch (Regular & Self Supporting)
3. Students of VII semester B.E. (Aero) have to pay an additional fee of Rs.1,000/- towards Flight Training.
4. Examination fee has to be paid separately.

5. One time fee, refundable deposit, fee payable every semester should be paid through online using internet banking. (<http://www.aukdc.edu.in>) – Anna University Payment Gateway (AUPaG).
6. Tuition fee is exempted for Full Time SC/ST and UG First Graduate students only.
7. Candidates admitted to M.E Product Design and Development have to pay an additional fee of Rs.9,000/- per semester towards additional computer charges.
8. 7.5% Reservation is to be followed as per Government norms.
9. Differently abled students are exempted from paying semester fee (payable every semester) but they shall pay Sl.No 08,09,10 and 11 in one time fee (payable at the time of admission) along with Caution deposit (refundable).

The Director, Planning and Development thanked all the members for their valuable suggestions.
